CSC REQUIREMENTS

Required Club Activities:

1. Two (2) club workdays per year.

Normally one is held in the spring to prepare the grounds and assemble boats and one in fall to remove boats from the shoreline close the club grounds.

2. One (1) civic service workday per year.

This is required by lease from the City of Columbus.

Usually the Division of Watercraft sponsors a fall cleanup around the lake, but the activity could be any water related activity such as scout outing day on water.

3. Keep your selected boat launching area and trailer area maintained. Keep weeds and high grass trimmed around your boat. This is your responsibility.

Social Events:

The club sponsors 3 social events each year. Make use of the club grounds for your family outings. Portable Toilet service, grills, sail storage, trailer parking are provided. Be sure to secure your boat on the beach with anchors, winds can be furious. Carry insurance for any damage your boat can cause or receive by adding it to your home insurance.

CSC HISTORY

The Columbus Sailing Club was founded in the late 70's as a racing fleet within the Hobie Class Association. The club grounds are leased from the City of Columbus. Membership has ranged from 10 to over forty boats during the clubs existence. Our club has evolved from a racing format to that of family pleasure sailing.

On the grounds we have created a sailing beach from a large briar patch, constructed a shelter, storage areas, and trailer parking area. The shelter area is screened in with an available gas grill for picnics. Toilet facilities are available.

Membership is open to any beachable multi-hull sailing boat.
